

# Caterpillar® Certified Rebuild Solutions

- 1) Hastings Deering (Australia) Limited (**Hastings Deering**) is offering customers who purchase any Caterpillar® Engine and Drive Train Component Rebuilds and Machine Rebuilds or HD Reman Exchange equipment (**Component**) which qualifies for the Cat Certified Rebuild Program (**Caterpillar® Certified Rebuild**) (see example product range at clause 4 and 6 below) on a Hastings Deering Service Department invoice between 1 January 2021 and 31 December 2021 an Equipment Protection Plan (**EPP**) for Caterpillar® Certified Rebuilds (**Offer**).
- 2) Hastings Deering in its sole and absolute discretion will determine if the Component qualifies as and may be enrolled as a CAT Certified Rebuild Program for the purposes of the Offer and under the Cat Certified Rebuild Program Guidelines.
- 3) If Hastings Deering determine the Component qualifies as a CAT Certified Rebuild for the purposes of the Offer, Hastings Deering may issue a quote. To be eligible for the Offer, Hastings Deering Service Department field service or workshop services must be engaged to complete the rebuild, including labour to remove and install the component or complete the rebuild.
- 4) An EPP coverage period of 24 Months/4000hrs, whichever expires first, applies to qualifying CAT Certified Rebuild of Caterpillar Component Model numbers ADT 725-745, COM 814-836, HEX 312-390, MG 12-150, TTL 933-977, TTT D5-D9, WL 914-990, WTS 613-657 and OHT 769-776 or such other Component Model numbers as may be determined by Hastings Deering under clauses 2 and 3 above and is subject to the EPP terms and conditions, copies of which are available on request.
- 5) Subject to clause 9(b) below, for the Component Model numbers qualifying for CAT Certified Rebuild under clause 4 above, the Offer also includes subscription to HD Advantage (see product details at <https://www.hastingsdeering.com.au/buying/hdadvantage-program>) during the EPP coverage period of 24 Months/4000 hours, whichever expires first, on and subject to customer acceptance of the HD Advantage terms and conditions, copies of which are available on request.
- 6) An EPP coverage period of 24 Months/10,000hrs, whichever expires first, applies to qualifying CAT Certified Rebuild of Caterpillar Component Model numbers UMT AD30-AD60, UML R1300-R3000, WD 844-854, OHT 777-797, TTT D10-D11, WL 992-994 and MG 16-24 or such other Component Model numbers as may be determined by Hastings Deering under clauses 2 and 3 above and is subject to the EPP terms and conditions, copies of which are available on request.
