 - a. The freight cost calculated and displayed to customer at <https://www.parts.cat.com/en/hastingsdeering> on the "Shipping and Billing" page will exclude GST, which will be charged to the total Order amount on the "Order Summary" page, before the Parts Order is checked out;
 - b. Hastings Deering delivers Parts Orders to customers via its preferred carriers only: Followmont within Queensland or Toll outside Queensland. Orders may be grouped together or delivered separately at Hastings Deering's sole discretion during business hours (Monday to Friday between 6am and 6pm) subject to the applicable carrier's standard road freight lead times (one to seven business days, depending on delivery location or as varied from time to time by the carrier). Hastings Deering is not in any way responsible for delays in delivery via its preferred carriers.  - b. Parts Orders placed on other channels offered by Hastings Deering, e.g. over the counter, by telephone, via product support representatives;

Oversized items are defined as consignments greater than 2.4 meters wide or 2mtrs tall and 4mtrs long;

 - e. Inbound freight; and
 - f. All delivery related freight, expenses, costs or charges other than Standard Freight Charges.
